RESEARCH ACTIVITY

LEADERSHIP, SYNERGISTIC RESEARCH ACTIVITIES:

- Urban & Metropolitan Studies. I assembled a team of urban-focused scholars from five colleges to create a pair of multi-disciplinary certificate programs (one each for undergraduate students and graduate students) in urban & metropolitan studies. I managed the approval process for both certificate programs and currently serve as Director of the programs. We are in our first operational year and are seeing considerable interest from students.
- "MixedMetro.com: Mapping Segregation and Diversity in America's Cities" website provides interactive cartographic experience examining the racial configuration of the residential landscape in US cities. The interactive mapping tools used on this site are based on Google's Maps API and produce cartographic overlays. Initial development was supported by the Russell Sage Foundation and the National Science Foundation and focused on 16 metropolitan areas. We have now expanded the number of metropolitan areas to the 53 that have population over 1,000,000 (without the mixed-race household concentration layers) and have added 2010 Census data. The website comes with map analysis metrics in the form of transition matrices that depict the patterns of neighborhood change over time. This website and the published research on which it is based has been spotlighted by *U.S. News and World Report's "At The Edge"* blog, *The Atlantic Cities* website, and *The Washington Post*.

I formed and lead this Work Group for a National Institute of Mental Health-funded Developing Center Grant (Gene Brody, Velma McBride Murry and Anita Brown, Co-PIs). Work Group outcomes include review papers, pilot research projects and a major research proposal funded by the Centers for Disease Control.
