COURSES TAUGHT

GEOG 8230 Seminar in Race and Racialization

This seminar critically engages the intersections between racialized subjectivities and geographic spaces and places. The readings center on North American cities and communities. The intent of the course is to engage in spirited discussion of our long-troubled understanding of the nexus between "race"/"ethnicity" and North American urbanization. Geographers and geographically-minded scholars increasingly ground their work in a variety of critical theoretical perspectives and the proposed readings allow us to assess recent innovative work in this area.

GEOG 8305 Social Theory in Geography: Exploring Qualitative Research

A graduate research seminar that engages students with readings and debate about the purpose, scope, and procedures of qualitative research, especially as applied to human geography. Readings are drawn from anthropology, geography, sociology, and women's studies, and address a range of qualitative methods, including interviews, participant and non-participant observation, ethnography, action research, and discourse analysis. The course engages students in key theoretical debates relevant to qualitative research.

GEOG 8260 Environmental Geography: Geographic Perspectives on Environmental Justice

A graduate research seminar that explores the way the concept of environmental justice has been framed by academics, by environmental justice movement activists, and by policy-makers. Students are encouraged to think critically about the form and implications of competing arguments about the nature of environmental injustice and inequity on one hand, and environmental justice and equity on the other.

GEOG 6910 Seminar on Research Design and Proposal Writing

A graduate seminar in which students develop critical perspectives on strengths and weaknesses of research proposals, and work iteratively in circle of peer and instructor review to develop and refine a research proposal.

GEOG 6305/4305 Introduction to Qualitative Research

This course introduces students to the nuts and bolts of research practice, with emphases on data collection and data analysis, and to a lesser extent, holistic research design. Students engage first-hand in interviews, focus groups, participant observation, and various approaches to data analysis. Work is balanced between individual and group work.

GEOG 4860 The Industrial Food System and its Alternatives

This course critically examines the historical and geographic development of the industrialized global agro-food system. Students critically examine the conceptual and policy-related possibilities for, and limitations to, alternatives to the global agro-industrial food system, such as organic food production, local food movements, and urban food systems.

GEOG 4690 Athens Urban Food Collective

A service-learning course that provides students with hand-on experience and an opportunity to earn academic credit working on issues of local food production and distribution. The key focus of work through the AUFC is to spur critical thinking about and active engagement with the problem of food insecurity among people living in poverty in ACC.

GEOG 3660 Geography of Breakfast Commodities

An advanced course designed to foster geographical thinking about how land, labor, environmental and trade practices affect agricultural producers and consumers in different regions of the world, and shape dynamic geographies of food commodities. Substantive foci include the history of production and global trade in coffee, sugar and bananas, recent debates over bio-technology and genetically modified organisms, and intersecting arenas of food and agriculture-related policy.

GEOG 3630 Introduction to Urban Geography

An upper level course that introduces students to key concepts in urban geography, major themes in the history of (Western) urbanization, and major theoretical approaches to urban geography

GEOG 3510 Cartography and Graphics

A mid-level course that introduces students to thematic map design principles and data considerations, and develops a hands-on understanding of mapping software and the implications of different map choices for cartographic communication.

GEOG 1101 and GEOG 2010H (Honors) Introduction to Human Geography

An honors introductory course that introduces students to key concepts and sub-disciplines of human geography.
